What are some of the strengths and/or accomplishments of your program?

The Marion Health Family Medicine Residency Program received ACGME accreditation in 2023 on the first attempt and fully matched all six residency spots before the SOAP. The residency has already started a pre-orientation program; we have met three times with our residents, and two more meetings are planned, to better prepare them for the transition to GME.

What barriers have you had to overcome in developing your program and how did you overcome them?

Two barriers we have faced are financial constraints and faculty recruitment. In addition to the RRPD Grant awarded in partnership with the Indiana Rural Health Association, we secured an Indiana GME Residency Expansion Grant to further support the start-up phase of the residency. We have also hired a recruitment agency, which has led to multiple possible new hires in the next two months. **Describe the area you serve and what appeals to you most about the location.**

Marion is a rural, underserved, high-need area in the middle of Indiana. What appeals to us most about Marion is the opportunity to make a real difference in the care of our patients and the community.
